RECOMMENDTION:

Staff recommends awarding Contract No. 204-18 for the Westley Bunkhouse to Scott Redenbaugh for the bid amount of \$188,250.00.

SUMMARY

The Bunkhouse project is located in Westley and will consists of ten (10) Single Occupancy Rooms. The Board of Commissioners approved resolution number 17-18-15 in January 2018 authorizing the procurement of the rehabilitation financing for the Bunkhouse Project. The Board approved resolution 17-18-19 approving the execution of a loan agreement for \$250,000.00 to provide rehabilitation financing for the Westley Bunkhouse Project.

The Housing Authority initially solicited bids for a General Contractor to perform the reconfiguration/rehabilitation of the Westley Bunkhouse in May of 2018 but had no responses. The Invitation for Bid (IFB) was re-published and additional time was provided to allow contactors to submit bids for this design build project. The re-published (IFB) No. 204-18 progressed as follows:

- May 7, 2018: The solicitation was published online on the Housing Authority's website.
- May 7, 2018: Advertisement was emailed to 19 contractors and potential bidders.
- May 15, 2018: A non-mandatory pre-bid meeting was held at Westley Bunkhouse site, which 2 interested persons attended.
- July 3, 2018: The IFB closed, with 2 firms having submitted bids:


a) Scott Redenbaugh (Modesto) (\$188,250.00) b) A&P Construction (Turlock) (\$335,000.00)



Scott Redenbaugh was the apparent low bidder, and upon review of the bid package by staff, was also the lowest responsive and responsible bidder.

Recommended Action:

- 1. The contract for construction is awarded to Scott Redenbaugh, for \$188,250.00 (One Hundred and Eighty-Eight Thousand Two Hundred and Fifty Dollars and Zero Cents).
- 2. The item has been budgeted and funds are available from an approved loan provided through F&M Bank.
- 3. The Executive Director is the designated Contract Officer and is authorized to execute the aforementioned contracts and to act on behalf of the Authority during the administration of this contract.
- 4. This Resolution shall take effect immediately.
