#### **SUMMARY**


The Housing Authority solicited bids for hiring a Contractor to perform the repair of Exterior painting of various Public Housing units located in Modesto by publishing Invitation for Bid (IFB) No. 217-19. IFB No. 217-19 progressed as follows:

- February 19, 2019: The solicitation was published online on the Housing Authority's website.
- February 8, 2018: Advertisement was emailed to 13 painting contractors and potential bidders, including 3 plan-room/exchange-houses.
- February 21 & 24, 2019: Published in Modesto Bee.
- March 11, 2019: The IFB Closed with the following results:

# RESOLUTION APPROVING THE AWARD OF CONTRACT FOR EXTERIOR PAINTING FOR PUBLIC HOUSING UNITS IN MODESTO

**WHEREAS**, the Housing Authority of the County of Stanislaus desires to award contract for exterior painting of various Public housing units in Modesto; and

WHEREAS, proposals for the completion of this work were solicited in accordance with the Authority's procurement policy; and

**WHEREAS**, the completion of this work has been budgeted and funds are available from Capital Fund Program; and

**NOW THEREFORE BE IT RESOLVED** by the Board of Commissioners of the Housing Authority of the County of Stanislaus, that

- 1. The contract for exterior painting for Public Housing units in Modesto is awarded to D & T Painting in the amount of \$246,000.00 (Two Hundred Forty-Six Thousand Dollars and Zero Cents).
- 2. The Executive Director is designated the Contract Officer and is authorized to execute the aforementioned contracts and to act on behalf of the Authority during the administration of these contracts.
- 3. This Resolution shall take effect immediately.
